REQUIREMENTS: Location of demonstration for the day of event will be at the discretion of the Bride, but a table/work area needs to be available along with ample lighting for the makeup artist.

LIABILITY: All brushes and products are kept sanitary and are sanitized between every makeup demonstration. Any skin condition should be reported by all clients to the makeup artist.

Client(s) agree to release the makeup artist (Blair Griffin) from liability for any skin complications due to allergic reactions.

CANCELLATION POLICY: Cancellations must be made (21) days prior to your reserved date or you will be responsible for the total amount of services agreed upon in this contract.

PHOTO RELEASE: I authorize my makeup artist to use my photos for her websites, portfolio, and any promotional advertisement or professional page online.

I, Blair Griffin, agree to be available for unlimited contact prior to event, supply all materials, and will be promptly available at required time.

I, as the Bride, agree to the prices, policies, and timeline listed in this contract. I agree to the non-refundable deposit to secure my wedding date. I agree to pay the complete balance (7) days prior to my wedding. I will comply with the cancellation policy and understand that no refund will be given for missed appointments. I also understand that I am responsible for balances from any members of my party who fail to provide payment.
